Come join us on a cruise on the Clear Lake Queen, 29 April 2000. The Queen is a three-deck paddlewheeler that carries 150 passengers with dining accommodations for 96 and a bar on the second deck. Clear Lake is the largest natural lake in California, with 127 miles of shoreline. Believed to be the oldest (4 million years) lake in North America, the lake and surrounding area abounds in Indian folklore. The three-hour cruise offers ample time to view the lake and surrounding mountains. Mt Konocti, although dormant, is still listed as an active volcano and is clearly visible from the boat. All dining tables have a window view. The on-board chef promises a delicious luncheon.

The cruise, including lunch, tax and tip costs \$25 per person. Make reservations by April 10<sup>th</sup> by contacting George Thompson 707-994-4143. Messages may be left on the answering machine.
