Although sketchy we pieced together that Bill's 20-year Air Force career was spent almost entirely in AFTAC. While attending tech school at Keesler AFB in the 50s he was picked in the second draft of students to go to "B" school at SPINSTRA. His numerous AFTAC assignments included the WFO (Depot), Turkey, Encampment (WY), HQ in Alexandria, and Hawaii. While serving as an enlisted "99" he was selected to attend OCS and returned to AFTAC as a commissioned officer. He was involved in a number of site surveys including those for Dets 415 and 421, and he participated in nuclear tests in the South Pacific and at the NTS. He retired from the Air Force in the early 70s and in the 1990 timeframe worked with residents of Encampment, WY to set up an AFTAC display in the Encampment Museum. The display included the AFTAC and local detachment history along with a seismometer and other artifacts. He later obtained a develocorder for the museum display which still exists to this day.!
