3) Reports:

- b) Outgoing Treasurer Butch Kemna gave the Treasurer's report. For the quarter just completed, we had a beginning checking balance of \$1,332.03. During the quarter, deposits were made of \$75.00 for membership dues and \$0.18 for three dividend payments. No withdrawals were made. The reconciled total balance was \$1,407.21 as of 8 Dec 2025.
- c) Membership Chairman Allen Pentecost gave the membership report. As of 8 Dec 2025, the total active membership stood at 118, of which 117 were life members. Address and/or email changes were made for Curtis Riggs and Alan Davis. Members removed for disabled phone numbers and email were John R. Smith, Preston T. Jones Jr. and Ronald C. Carpenter. - d) Webmaster Bob Fitzgerald gave the web activity report. There were 4526 visitors in September, 6119 in October, and 6531 in November. The most popular page was the Events page in September and the Departed page in October and November.
